#### Dear Friends,

This past year, your generosity made a measurable difference. Together with our more than 250 volunteer physicians — leaders across every specialty — MAVEN Project connected frontline clinicians with expertise, mentorship, and guidance that transformed care. The numbers on the following pages tell the story: 123 new clinic sites supported, 9,743 consultations delivered, 1,017 mentorship engagements, and 214 educational sessions. And behind every number is a person whose care and confidence were transformed.

The need is growing. Across the country, millions are expected to lose coverage as Medicaid eligibility becomes harder to obtain and maintain. Patients are already arriving at community clinics later in the course of illness and are presenting more advanced conditions while having fewer resources to work with. For frontline clinicians, the weight of these realities can be overwhelming. MAVEN Project is stepping up — ensuring that primary care providers, often working in the most resource-limited environments, never face these challenges alone.

We are also preparing for the future. Artificial intelligence is expanding rapidly in health care, but on its own it cannot replace experience or context.

MAVEN Project is not behind — we are ahead. By layering Al's reach with the wisdom of our volunteer specialists, we help clinicians refine questions, clarify information, and interpret suggestions so decisions about testing, treatment, and diagnosis are informed by clinical experience, practical and tailored to each patient's circumstances. In this way, we support both patients and providers while keeping care grounded in real world medicine.

**Your partnership makes this possible.** Together, we are expanding a system where every provider has access to expert guidance, and every patient — no matter their insurance status — can receive care informed by the very best of medicine.

#### Safety net clinics will face unprecedented strain

Safety net providers excel in primary care but often face steep challenges when cases become complex. Geography, cost, and systemic inequities severely restrict specialty access. MAVEN Project fills this void, ensuring clinicians are never left to navigate difficult cases alone. Patients benefit from timely, expertinformed decisions, and clinicians gain the confidence and support to deliver the highest standard of care.

With federal changes expected to push millions more out of affordable coverage, safety net clinics will face unprecedented strain.¹ MAVEN Project stands ready to meet this demand — breaking down barriers so every patient, regardless of location, income, or insurance, can receive high-quality comprehensive care.



Our platform serves as a virtual meeting place where safety net primary care providers (PCPs) can connect with specialists through video or eConsults. As if they were just down the hall, our volunteers help PCPs accurately diagnose and develop targeted treatment plans, drawing upon the latest clinical knowledge and years of hands-on experience. This approach ensures that patients receive the right care without delays or the need to travel, all while staying in the trusted hands of their PCP.



## Our Services: Mentoring







#### Volunteer of the Year: Carrie Horwitch, MD



"Sustainable growth and development are critically important in medicine and have been huge themes throughout my career. By educating clinicians and raising their awareness, capability, and capacity, we are doing so much more for patients — for our

entire country — than we could by addressing one patient at a time. I'm in a cognitive specialty, which means I don't do a lot of procedures. Internal medicine is all in the patient's history and physical exam, which take time to understand. 

"At MAVEN Project, we're injecting information at the point of use. You actually get to talk to a specialist with expertise in the area you need about a specific patient, and on the spot, they'll help you figure out what you need to do for that patient. And now that practitioner knows how to help the next patient. They're learning by doing.

A lifelong goal of mine has been to improve care for the medically underserved. So I'm very pleased that MAVEN Project gives me this

opportunity and that it even exists. We are improving the care people get in community health settings."

#### Innovator Award recipient: Claude Rogé, MD



"If you're a provider in a small clinic in a remote area, you don't have a lot of options for help. You can try calling the specialist in your area for advice, but you might not reach them. You can go to the web for medical research, but you have to know how to

decipher what you find. You can't present that system with a patient; you're just collecting data and seeing if it can apply to your patient. There's a huge difference in being able to talk to someone, especially someone like me, who has been practicing for a long time. We have the practical clinical experience to help newer providers manage their patients. This is so much more valuable — and efficient! — than trying to figure it out yourself by searching through all the data you can find. Your patient gets the advice or the treatment they need, and now you know what to do when those issues come up again — and they very likely will!"

#### Educator Award recipient: Najah Musacchio, MD



"Over many years of working with primary care providers to treat mental health, I've observed over and over that when clinicians can consult mentors about mental health treatment, they are empowered to push themselves beyond their normal scope. This is exactly

how we support clinicians through MAVEN Project: We're giving them the tools and confidence they need to single-handedly help a lot of patients amid a national mental health crisis."

#### Profile: Dr. Katherine Upchurch



For the past 10 years and through many exceptional roles, Dr. Katherine Upchurch has transformed patients' lives.

As one of MAVEN Project's first volunteers in 2014, Dr. Upchurch began by providing valuable consults in her specialty of rheumatology to frontline clinicians, understanding the power of telemedicine when it was much-less common. She then expanded her efforts to meet the need for the development of comprehensive

educational program that emphasizes early intervention — critical for conditions like rheumatoid arthritis in helping to prevent life-long disability for patients.

Most recently, Dr. Upchurch has made a generous financial contribution to MAVEN Project to support the organization's overall efforts to provide access to underserved patients.

Dr. Upchurch's true spirit of giving as both a volunteer and a contributor — spoiler alert — was also recently recognized by MAVEN Project as she was named the 2025 Champion Award winner.



## Rhode Island Health Center Association (RIHCA)

that make it easier for health centers to do their important work without adding to their workload. The RIHCA learned about MAVEN Project at one of its monthly Clinical Leadership Committee Meetings. Based on the very positive experience of one Federally Qualified Health Center Chief Medical Officer, RIHCA facilitated access to this valuable resource to all the health centers in the state.

RIHCA was able to use a shared services model to enable access for all the health centers. By enabling access to MAVEN Project, RIHCA supports health centers in becoming the employer of choice by providing specialty expertise, mentoring, and education to their primary care clinicians. The service is especially helpful to new clinicians, offering a choice of providers and enhancing the patient experience through reduced specialist visits.



#### **Americares**

Americares is a global health and disaster relief organization that helps people and communities around the world access health in times of disaster and every day. Since 2024, via its California Thriving Local Health Clinic/Center (TLHC) Institute, Americares has sponsored free and charitable clinics in California as they partner with MAVEN Project to access educational and mentorship supports, as well as much-needed provider consults that reduce barriers to specialty care, which can be prohibitive for many low-income patients due to cost and distance.



#### **Horizon Health**

Horizon Health, a 27-site Federally Qualified Health Center, located across 19 communities in South Dakota, faced significant challenges in securing specialty care for its patients. Some specialties were located as far as three hours away, with no available public transportation or rideshare options. Horizon Health Care entered into a partnership with MAVEN Project to support staff through education, mentoring, and professional development.







Ziegler/Third Horizons/HC3

In June 2024, MAVEN Project was featured at an event partnering with Ziegler and the Health Care Council of Chicago (HC3), managed by Third Horizon Strategies. The gathering brought together civic and health care leaders to examine the unique challenges facing Chicago's safety net and to discuss collaborative, innovative solutions to address specialty health care needs to the local community.

The program included perspectives from Ziegler leadership, HC3, and Third Horizon Strategies alongside MAVEN Project's leadership and physician volunteers. Guests also enjoyed a networking reception with live music on Ziegler's 20th-floor patio overlooking the city.

It was incredibly meaningful to bring together civic and health care stakeholders to discuss the challenges within Chicago's safety net and explore the innovative solutions offered by the MAVEN Project. As MAVEN Project embarks on a period of intensive growth to expand access to comprehensive care for underserved patients nationwide, collaboration with thought leaders, health care partners, and philanthropists will be essential. Illinois is grappling with a significant health care workforce shortage, and the MAVEN Project's unique supply of veteran subspecialist volunteers can help bridge the care gap, relieve burnout, and build healthier communities.

By consolidating our IT services and migrating to a managed services model, we're building a more robust, scalable foundation to support our growth.












